This is Ethan, my beautiful son, who sadly lost his life nearly 10 years ago.

Next to him is Rachel, who was his best friend. Rachel's mum and I used to say they would get married one day...

When Ethan was born at 26 weeks he was diagnosed as being profoundly deaf and having severe cerebral palsy. Cerebral Palsy Alliance helped us in every aspect of Ethan's life, from eating to sleeping. Ethan had a huge amount of equipment he needed just to get through a day. Ethan required over \$200,000 worth of equipment throughout his short life-span.

Ethan's therapists included his Physio, his Occupational Therapist, his Speech Therapist, his Conductive Education teachers, his equipment specialists and his Hydro- therapists. And we would spend at least 3-4 days a week if not more at the then, Spastic Centre. It became our second home. ▶

❧ A better quality of life ❧

Physical limitations and pain aren't the only challenges faced by people with cerebral palsy. Other people's attitudes, lack of access to technology and facilities, and even a lack of social connection can also hamper them.

Your bequest will support Cerebral Palsy Alliance's work to improve the quality of life for people like Jessika.

Jessika has the most severe form of cerebral palsy and needs 24-hour personal assistance. But thanks to a range of specialised equipment and technology, she is able to communicate, attend school, be cared for at home, go on holiday and enjoy the friendships of girls her own age.

She's helped by a lightweight aluminium wheelchair and an electric height-adjustable sleep positioning system

that makes bedtime more comfortable. Jessika's mum Jayne can now bathe Jessika in a special shower bed rather than struggling with a shower chair. And a special adjustable supporting chair means Jessika can join her family at the dinner table or play with her dog on the floor.

These are ordinary everyday experiences for most people – but priceless gifts for Jessika and her family.

And they wouldn't be possible without people like you.

Promising research

The cause of cerebral palsy is still unknown for most families. Previous theories about difficult births have been shown to be inaccurate in the majority of cases. A lot of work needs to be done to understand why some children, and not others, develop cerebral palsy.

Thanks to donations and people investing in research through their Wills, Cerebral Palsy Alliance is a leader of this research in Australia.

Professor Alastair MacLennan is the Head of the South Australia Cerebral Palsy Research Group. He and his colleagues are conducting research involving children with cerebral palsy and their families. They are genetically analysing saliva samples and checking them against very comprehensive medical records. They hope to make connections between the health of children with cerebral palsy and their genes.

We have established global 'research clusters' to focus international collaborative attention to key areas: congenital anomalies; neonatal stroke; early identification and intervention; neuro-imaging; neonatal encephalopathy and regenerative medicine.

We fund a wide range of research projects every year through our grant program, both in Australia and around the world, including an important study about global newborn health and child disability in Africa and specifically in newborn brain injury and cerebral palsy.

Promising projects like these depend on guaranteed funding.

May Gibbs' Legacy

May Gibbs is one of Australia's best loved classic children's book writers and artists. When she died, May Gibbs bequeathed her works to two charities, one of which is Cerebral Palsy Alliance.

Lisa lives with her husband David, and son Aaron. She’s a self confessed animal lover, and the family share their house with two dogs, three cats, two rabbits, two guinea pigs, a turtle, a fish and a rescued dingo. Like many of the people who have chosen to leave us a gift in their Will, Lisa has no personal connection with cerebral palsy. But her own

experiences have given her an understanding of how physical disability can affect an individual and their family.

“My husband and I had to update our Wills to reflect a change in our family circumstances. I thought it would be a good time to include Cerebral Palsy Alliance. Our son is looked after, so a little going elsewhere won’t affect him.”



❧ The best way to make a bequest ❧

There are a few different ways you can include Cerebral Palsy Alliance in your Will, but we recommend a residual bequest. It is very easy and ensures your loved ones are looked after first.

This type of bequest is a gift of whatever is left of your estate (or a percentage of it) after all your other gifts, taxes and debts have been paid.

A residual bequest lets you decide exactly how much of your estate you want to leave to your family and loved ones, and then leave the

remaining proportion to support people with cerebral palsy and their families.

It also means that even if your financial circumstances change, you'll still be leaving the proportions you intended to. And by dividing your gift by percentages, you can be confident it will retain its value over time.

There are other types of bequests. You can leave a specific amount and/or asset, or make a gift that's contingent on a particular event – such as your primary beneficiary not surviving you, for example.

❧ What to say in your Will ❧

It's important to use the correct wording and legal names when making a bequest. For yours and your solicitors' reference, we recommend the following wording after your nominated gift:

'I give to Cerebral Palsy Alliance
(ABN 45 000 062 288)

a) All of my residuary estate

OR

b) x percentage of my residuary estate

OR

c) The sum of \$ _____

OR

d) List of assets

to be used for the general purposes of Cerebral Palsy Alliance ABN 45 000 062 288 (or Research Foundation of Cerebral Palsy Alliance) and I DIRECT that the receipt of the public officer or other proper person for the time being of this organisation shall be a full and sufficient discharge to my trustee for the payment of such benefit.'
